Components may be despatched directly from the original component Manufacturer. In such cases, the Manufacturer shall meet the requirement of this specification, the relevant Generic and Detail Specifications, the Orderers Purchase Order and, for qualified components, the PID.

5.2 DESPATCH BY THIRD-PARTY SUPPLIERS

Components may be ordered from and despatched by authorised distributors, procurement agents or other authorised
